

### **Privacy and cookie statement**

Silent Disco Box respects the privacy of our website visitors. We see it as our responsibility to protect your privacy. On this page we will inform you about the type of data we collect when you use our website, why we collect this data, and how we use it to improve your user experience, so that you are informed about the exact way we work.

This privacy statement applies to the services of STILLEDISCO.INFO and Silent Disco Box, hereafter to be called Silent Disco Box. By using this website, you agree to the privacy statement.

### **Processed personal information**

Silent Box may process the following personal information:

- Your first or last name
- Your address
- Your telephone number
- Your e-mailaddress
- Company name and information (insofar these are considered personal information);
- Your IP-address
- Your VAT number if you are a business client
- Cookies

Silent Disco Box can process personal information about you because you use Silent Box services and/or because you have indicated them on the contact form to Silent Box. This information is used to perform the service. All information is stored on third-party secured servers, for example Strato.

### **Purposes**

We process your personal information for the following purposes:

- Permitting access to our website [www.silentdisco.info](http://www.silentdisco.info).
- The usage of functionalities on our website;
- Entering and performing agreements related to our services;
- Establishing contact with you, if you request it;
- Acquiring insight in the usage of our website;
- The improvement and evaluation of our website and our services;
- Making it possible for you to e-mail, print out, or share a webpage through social networks like Facebook, Twitter and LinkedIn;

We do not collect or use information for any other purposes than the purposes mentioned above, unless we have attained your permission prior, or unless we can do so based on regulations.

### **Storage period**

Silent Disco Box does not store your personal information longer than strictly necessary to achieve the purposes for which your personal information is collected. Your personal information will not be stored longer than one year.

### **Transfer of information to third-parties**

We do not transfer your information to third-parties without your prior permission, unless this is necessary in the context of performing the agreement, or unless we are obligated by regulations to do so.

### **Cookies**

We collect information for research, in order to attain a better insight in our clients, so that we can tune our services to them. The website uses "cookies" (text files that are stored on your computer) to help the website analyse how users use the site.

Our website uses cookies or similar technologies where information is stored on and/or read from the device (for ease of reference all such techniques will be called 'cookies' in the rest of this text) in order to:

- Enable functionalities of the website and to protect the website (technical or functional cookies);
- Analyse the usage of the website and improve the website based on this (analytics cookies);

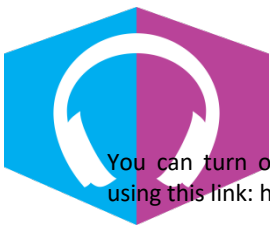
### **Technical or functional cookies**

Some cookies ensure that certain parts of the website perform up to standard, and that your user preferences are known. For example, cookies can be used to render fonts correctly, remember your user session on the webserver so you can view the website, or to remember a search term which was used for searching within the website or a chosen search filter. The technical and functional cookies we use store the user information and concealment of information after the first visit to the website.

### **Analytical cookies**

Furthermore, we use cookies from Google Analytics, so Google can give us insight about how our website is being used, give us reports about the website to us, and give us information of the effectiveness of our campaigns. The information that we attain in this process, will be transferred to Google and stored by Google on servers in the United States, including your IP-address.

We have a data processing agreement with Google, wherein agreements are outlined about the handling of the collected data. We have not granted Google the permission to use the acquired data for other Google services. Google can however transfer information to third-parties if Google is obligated to do so by law, or in the case that third-parties process information in the name of Google. We do not have any influence on this. #### **Cookies deletion**

Many cookies have an expiration date. If there is an expiration date for the cookie, the cookie will be automatically removed as soon as this expiration date passes. You can also opt to manually delete cookies before the expiration date passes. Please refer to the manual of your browser for more information on this.

#### **Third-party websites**

This privacy- and cookie-statement does not apply to third-party websites that are connected to our website through links. We cannot guarantee that third-parties will handle your personal information in a trustworthy or secure manner. We advise you to read the privacy statements of these websites before using the websites.

#### **Changes**

This privacy statement is tailored for the use and possibilities of this site. In the case of adjustments and/or changes to the site, this privacy statement could also be changed. It is advisable to consult this privacy statement regularly.

#### **Sharing with third-parties**

Silent Disco Box only transfers your personal information to third-parties in this is needed to perform an agreement made with you, or in order to comply with a legal obligation. Other cases may include the internal sharing of information. Employees of Silent Disco Box are obligated to respect the confidentiality of your information.

#### **Your rights**

You have the right to view, correct or request removal of all your personal information.
